Review of Literature

The work of Boissier et al. (1973) has been seminal in this field. They believe that society typically perceives the sexuality of elderly persons as constrained. Winn et al. (1982) examine the persistence of sexual activity among the elderly across several countries, suggesting that cultural influences may significantly influence their sexual behaviour.

Bauer et al. (2007) investigated sexuality in older

adults and noted its status as a "neglected area in research" in their study titled "Sexuality, Health Care, and the Older Person." Like other contemporaries, Sinkovic et al. (2019) conducted a qualitative analysis of sexual ageing, highlighting the socio-cultural dimensions of intimacy among older individuals. They want to emphasise the influence of closeness on "personal significance and relevance" in the final stages of human life.

Lee et al. (2016) conducted longitudinal studies on ageing and affirmed that sexual health is a fundamental aspect of well-being in later life, since older individuals maintain their sexual impulses despite the physiological changes associated with ageing.

Orr et al. (2019) emphasises the necessity of elucidating the sexual demands and unfulfilled experiences of the elderly, dismantling stigma, encouraging help-seeking behaviour, and integrating the findings into healthy ageing policy measures.

Stigma is a detrimental view of an idea aimed at a specific group of individuals, influencing their behaviour towards that group. This topic has garnered significant attention in both research and therapeutic approaches worldwide.

Link and Phelan (2001) provide a comprehensive definition of stigma in "Conceptualising Stigma." They propose that six essential conditions for stigma exist: labelled disparities, stereotypes, alienation, status loss and discrimination, power, and emotional reactivity. **Stereotypes** are exaggerated views linked to a category that are prevalent and deeply ingrained in verbal, written, and visual contexts within society. Stereotypes of ageing encompass preconceptions and generalisations regarding the expected behaviour and experiences of individuals at or above a specific age, disregarding individual variances and unique circumstances, as elucidated by Ory et al. (2003).

Ageing is the time-related decline of physiological capabilities essential for survival and reproduction. The traits of ageing, as differentiated from agerelated disorders, impact all members of a species.

Intimacy is the sensation of emotional and physical proximity between two individuals over time. From a sociological standpoint, closeness augments emotional well-being and is a systematic construct like to family. Intimacy is a personal experience of demonstrating affection, ranging from caregiving to sexual intercourse. The yearning for intimacy persists with age, and there is no age at which closeness, encompassing physical intimacy, is deemed improper.

The Influence of Cinema on Perspectives

Mass media serves as a global source of entertainment. Films have been recognised to affect mood and emotional control across all age groups. Bollywood cinema plays a substantial role in the film business, attracting a large following both in India and beyond.

Dwyer (2020) asserts that Bollywood cinema has emerged as a global phenomenon, with films attaining a worldwide following. The films depict Indian culture and traditions and have profoundly influenced global perceptions of India.

In 2022, Luan et al. investigated the impact of cinema viewing on social cognition, discovering that watching films can improve individuals' empathy and perspective-taking skills. In the Indian context, this conclusion was corroborated by Chakraborty and associates (2023), who examined the influence of Bollywood cinema on cultural attitudes and values in India, discovering that films can affect public opinion on several social issues. The research underscores Bollywood cinema's capacity for social commentary and cultural critique.

Purpose

This paper intends to examine the portrayal of stigma and ageing in Hindi films, focusing on the elderly and their intimate needs. Films illustrate a prevalent societal interest in exploring emotional connections among the elderly, particularly during widowhood. Societal myths serve as psychological obstacles for the elderly in articulating their needs to loved ones. They also perceive themselves as burdens to their families. The sexuality of the senior population requires more examination.

Methodology

Bollywood movies were analysed to identify pertinent stigmas associated with widowhood, rebuilding romantic relationships, confronting stereotypes, and family dynamics, particularly as they pertain to the elderly's dependence on their families.

Discussion

Our social conditioning expects old age to be associated with asexual preferences, especially for women much against to their wishes. Physically comforting intimacy is desirable irrespective of the age. But social norms make it easy for men to fulfil their desires, whereas women must hide and seek love in the face of loneliness. The decline in libido and desire over time can be attributed to various factors such as routine, familiarity, hormonal fluctuations, health concerns, or monotony. However, a significant portion of the decrease in behaviour among older individuals is perpetuated by societal norms and cultural expectations. Kapoor and Sons, a Hindi movie released in 2016, stars the late actor Mr. Rishi Kapoor. The story is about two brothers (Fawad

Khan and Sidharth Malhotra) who visit their dysfunctional family for their grandfather (Rishi Kapoor). He lives joyfully at the age of 90 and wishes to get a family photograph mentioning Kapoor and Sons and frame it in the hall of his house. His son and daughter-in-law have an estranged relationship, which their sons and father-in-law largely ignore. The actor is seen as "the happy-go-lucky daddu," who is shown as a weed-smoking, porn-watching octogenarian. He is acting as the glue for a family slowly crumbling under the load of anger and resentment.

He desires to connect with his grandsons, who stay away, but does not have a connection with his daughter-in-law or son, with whom he stays. Though he is dependent on his son and daughter-in-law for physical care, he is emotionally distanced from them and suffers from physical ailments.

Lipstick Under My Burkha, a Hindi film produced in 2016, narrates a tale of liberation from a strict environment. Four women embarked on a quest for liberation and pleasure. Set in the congested alleys of Mumbai, Lipstick Under My Burkha explores the clandestine lives of four women seeking some form of independence. Despite being constrained and confined within their environments, these four women assert their aspirations through subtle acts of bravery and covert defiance. In the bustling streets Mumbai, a 55-year-old widow reawakens her sexuality through a connection by phone romance. She is presented as the protagonist of an erotic pulp fiction novel entitled Lipstick Dreams. In her everyday life, she functions as the elderly matriarch and has adjusted to being referred to as "Buaji" (Aunty); she has nearly forgotten her own name and often contemplates a self-portrait from her youth. The cultivates a desire for uninhibited character sensuality, influenced by the raunchy pulp fiction she consumes and a muscular swimming secretly instructor who captivates her interest. This film does not pertain to ladies of any faith. It pertains to all women existing under the oppression of a rule of law

Results

The first movie breaks the stigma of an elderly man wishing to lead a carefree life and express his loneliness openly. In the second movie, an elderly woman must suppress herself as she is unable to come out in public and seek the companionship she is desiring. She must pretend to be a different person on calls to lure companionship and feel good about herself.

A clear distinction in gender comes from research done by Leiblum (2002) that explains causes for women's sexual problems, especially in old age, including shame, guilt, sexual abuse, interpersonal conflicts, depression, and religious and cultural

prohibitions. Life span Psychologists clarify myths around age and sexual desires in human beings. Many people may be astounded by the idea that, like young adults, people beyond their sixties are capable of being sexually active. It could be assumed that after 60 years, there is a drop in libido, and thus people become asexual. Pfeiffer et. al. (1972) examines how older men fear losing their sexual prowess, while older women fear being judged as disgraceful if they themselves overtly. Fear of judgement express comes more from the immediate family than from society at large. If at all intimacy becomes a concern, it could be due to compelling factors like chronic illness, depression, and the incapacitation or death of a partner.

Limitation

This study focused only on the socio-cultural (gender, marital status) aspect of geriatric expression towards pleasure seeking and did not consider any medical history. This study focused on film analysis as a methodology.

Conclusion

Movies depict a normal social interest in finding emotional connectedness in the elderly population, especially post-widowhood. Societal myths act as mental barriers for elders to explain their needs to their close ones, as they feel like a burden on their family.
